FACT SHEET 2015 MINNESOTA HOMELESS STUDY

Ramsey County: Characteristics and Trends

Of Those Experiencing Homelessness in Minnesota

Every three years, Wilder Research conducts a statewide study to better understand the prevalence, causes, circumstances, and effects of homelessness. The study includes face-to-face interviews throughout the state with people who meet the federal definition of homelessness, as well as a count of people who were homeless on a single night in late October. The most recent study was conducted on October 22, 2015.

This fact sheet highlights findings from interviews with people experiencing homelessness in Ramsey County. Wilder Research staff and trained volunteers conducted interviews in emergency shelters, domestic violence shelters, transitional housing, and non-shelter locations such as encampments, hot-meal programs, and other drop-in service sites.

Homelessness in Ramsey County is up from the previous two studies

- Overall, the study found 1,787 homeless adults, youth, and children in Ramsey County. This is nearly 19% of the total count for the state (9,312), and is up 14% from 2012. (1,567).
- The 14% increase from 2012 to 2015 follows a decrease of 7% from 2009 to 2012; 2015 numbers are greater than they were in 2009 (1,685).
- The number of homeless children with their parents increased 15% from 2012 (469) to 2015 (541). Children represent 30% of the overall homeless population. Children and unaccompanied youth age 24 or younger are the group most likely to be homeless.
- 82% of homeless adults age 18 or older in Ramsey County have been in Minnesota for longer than two years.

Changes in Ramsey County vary from year to year depending on age group


- After decreasing from 2009 to 2012, the combined number of children and unaccompanied youth (age 21 and younger) experiencing homelessness in Ramsey County is greater than in 2009. There were 732 children and unaccompanied youth (age 21 and younger) counted in 2009, 676 in 2012, and 801 in 2015.
- There was a 10 percent increase in the number of adults age 22-54 experiencing homelessness in Ramsey County from 2012 to 2015, following a decrease of 14 percent from 2009 to 2012.
- There has been a steady increase in the number of older adults experiencing homelessness (up 14% since 2012).

In Ramsey County, nearly half of people experiencing homelessness are children and youth



The number of children, youth and older adults have increased from 2009 to 2012; other age groups decrease from 2009 to 2012, but are now back to levels similar to 2009

- The number of homeless children with their parents and unaccompanied youth (age 21 and younger) in Ramsey County increased steadily since 2009. The number of homeless children was up 15 percent over 2012 levels.
- While the number of homeless older adults (age 55+) found in non-shelter locations remained about the same, the number of older adults in shelter doubled from 2009 to 2015 (81 vs. 166).
- After a decrease from 2009 to 2012, the number of parents in Ramsey County, age 21 or younger, increased to a level similar to 2009.
- While the number of homeless parents, age 22 or older, in Ramsey County shelters remained about the same between 2012 and 2015, the number of homeless parents found in non-shelter locations increased dramatically from three in 2012 to 23 in 2015.
- There was an 11 percent increase in the number of homeless adults (age 22-54) without children in Ramsey County from 2012 and 2015, but that was preceded by an 18 percent decreased between 2009 and 2012.

Comparing numbers: Ramsey County and Hennepin County

It is helpful to look at homelessness as a regional issue, since the homeless population is highly mobile. Wilder's statewide data show differences in homeless numbers in the Twin Cities metro area versus greater Minnesota (these data tables can be found at www.mnhomeless.org). In the urban counties, there was a reverse trend in the counts of homeless people; counts in Ramsey County increased by 14 percent between 2012 and 2015, while counts in Hennepin County decreased by 15 percent. Some of the fluctuation in number of people between counties may be due to movement of homeless people as well as to the ability of outreach workers to locate people who are staying outside of the shelter system.

Availability of affordable housing is still a critical issue in Ramsey County

- 49% of homeless adults age 18 or older are on a waiting list for subsidized housing, with an average wait time of 12 months; another 13% were unable to get on a waiting list because it was closed.
- 30% of adults age 18 or older spent at least one night sleeping outside in the 30-day period before the study.
- The most common reasons adults left their last housing: 32% were evicted, 31% could not afford it, and 28% lost their job or had their hours cut.
- Homeless adults had a median income of \$633 during the month of the study and could afford an average of \$395 per month in rent (14% could not pay anything for rent).
- 66% of homeless adults report that they would only need an efficiency or one-bedroom apartment.

Employment rates for people experiencing homelessness in Ramsey County continue to rise after reaching a low point in 2009

For youth age 24 or younger, 51 percent were employed at the time of the 2015 survey; 22 percent were working full time. These rates are higher than employment rates for homeless youth statewide.

For youth age 24 or younger, 12 percent were homeless for less than one month and 52 percent were homeless for one year or more. Fifty-nine percent fit the MN definition of long-term homeless.

For youth age 24 or younger, 53 percent reported a serious mental illness, 66 percent reported a chronic physical health condition, and 10 percent reported a substance abuse disorder.

Eight percent of homeless adults in Ramsey County have served in the military; numbers are decreasing


