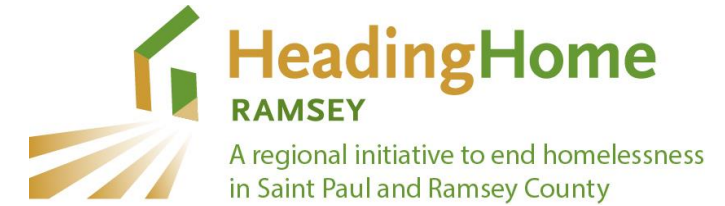

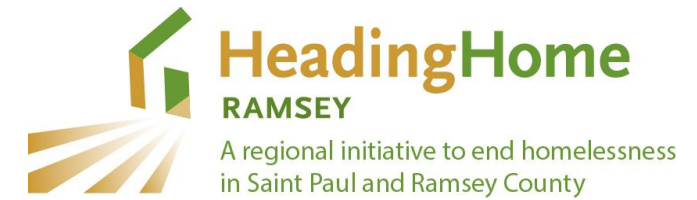

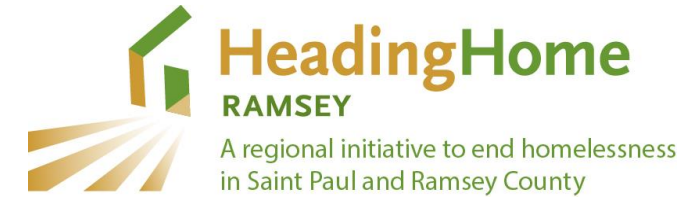

# Fy2019 HUD Funding for St. Paul/Ramsey CoC



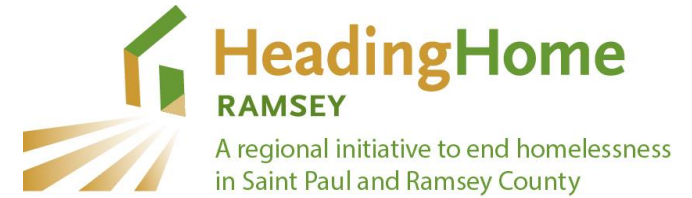
- **\$5,331,074** – Preliminary Pro Rata Need (PPRN)
- **\$6,793,228** – Estimated Total Annual Renewal Demand (ARD)
- **\$6,385,634** – Tier 1 (94%)
- **\$405,594** – Tier 2 (6%)
- **\$339,661** - Permanent Housing Bonus (up to 6% of Final Pro Rata Need (FPRN))
- **\$533,107** - Domestic Violence Bonus (up to 10% of Preliminary Pro Rata Need (PPRN))
- **\$846,144** – Reallocation funds available (part of Tier 1)
- **\$203,797** – Planning Grant (Collaborative Applicant only)

# Highlights of FY2019 HUD CoC NOFA



- About \$2.3 billion is available
- An additional \$50 million available for Domestic Violence (DV) Bonus Projects
- All project applicants must abide by the CoC deadline, meet HUD eligibility/criteria
- HUD requires CoCs to rank all projects into Tier 1 and Tier 2
- Ranking of projects is based on capacity, priorities, and past performance
- Performance-Based Decision
- Consolidated Project
- Transition Grants
- Expansion Grants

# Highlights of FY2019 HUD CoC NOFA

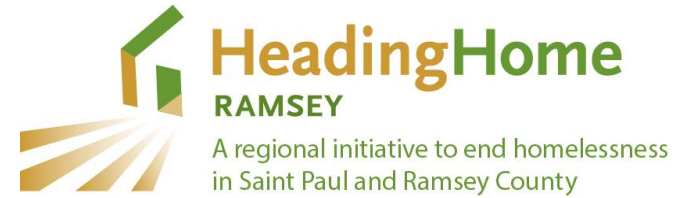


- \$846,144 in reallocation
- \$339,661 for new Permanent Housing Bonus
- \$533,107 for new Domestic Violence Bonus
- Domestic Violence:
  - Permanent Housing – Rapid Re-housing (PH-RRH)
  - Joint Transitional Housing and Rapid Re-housing (Joint TH and PH-RRH)
- Bonus or Reallocation:
  - Permanent Housing – Permanent Supportive Housing (PH-PSH)
  - Permanent Housing – Rapid Re-housing (PH-RRH)
  - Joint Transitional Housing and Rapid Re-housing (Joint TH and PH-RRH)
  - HMIS costs as carried out by lead agency (ICA only)
  - Supportive services only – coordinated entry (SSO-CE)

# HUDS' Homeless Policy and Program Priorities:

- Ending homelessness for all persons.
- Create a systemic response to homelessness.
- Strategically allocating and using resources.
- Using an Evidence-Based Approach. (New in FY2019)
- Increasing employment. (New in FY2019)
- Providing Flexibility for Housing First with Service Participation Requirements.

# St. Paul/Ramsey CoC's Priorities



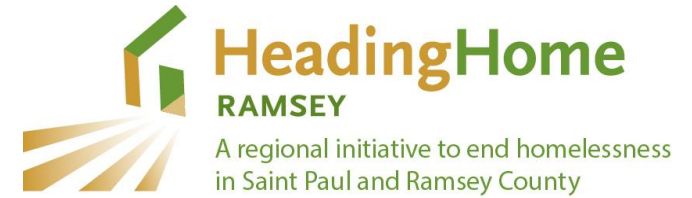
- Need for additional single adult/youth assessors and housing navigators (SSO-CE).
- Need for Rapid Re-housing (RRH) and Permanent Supportive Housing projects for families, single adults, and youth.
